## **Goals of the LAN**



**Increased adoption** of effective accountable care arrangements and individuals attributed to accountable care relationships.



Development of **equitable models**, including scaling of payment structures and design elements that promote care models that advance equitable outcomes.



Promote **multi stakeholder alignment** of shared APM design elements across purchasers, payers, providers, and patients.

#### How the LAN Defines Accountable Care

Accountable Care **centers on the patient**, and aligns their care team to support **shared decision-making** to help realize the best achievable health outcomes for all through equitable, comprehensive, high quality, affordable, longitudinal care.

### **Goal-Oriented Action**



The LAN and CMS have shared goals for 100% of **Medicare beneficiaries** the vast majority of Medicaid beneficiaries, and most Americans with private insurance to have access to accountable care relationships by 2030.

Coming out of the Public Health Emergency (PHE), APM adoption increased for two-sided risk models in 2022:

- 5 percentage point average **increase in models with "downside risk"** (significant shift away from fee-for-service), compared to a less than 2 percentage point average increase reported in the previous year.
- The most recent APM Measurement Effort survey collected by the LAN now includes data on the share of people in accountable care relationships.



# Multi-payer alignment to advance accountable care standards

LAN State Transformation Collaboratives support multi-stakeholder collaboration at the state level, providing support for convening, subject matter advisors, and resources in key areas of multi-payer alignment.

#### Other LAN efforts to promote alignment:

- Convening the National Health Plan Work Group
- Publication of the Multi-Payer Alignment Blueprint
- Enabling LAN mechanisms for engagement on CMS alignment initiatives (e.g., CMS Universal Foundation for Quality Measures; CMS/ONC MSSP eCQM standards)



# Alignment through primary and specialty care integration in accountable care

Success in accountable care requires **expanding effective payment reforms and supports** to **engage different types of specialty care.** 

To catalyze progress, the LAN has expanded its membership and is focusing on promoting primary-specialty care coordination in its work on best practices and multi-payer alignment.

#### Other LAN initiatives on primary and specialty care integration:

- LAN report on Aligning Clinical Episode Payment Models
- State Transformation Collaborative stakeholder engagement in the Making Care Primary Model, which promotes advanced primary care and specialty integration
- National Health Plan Workgroup focusing on promising practices
  for specialty care integration into accountable care

# Addressing diverse population health needs and increasing equity
